

PRIVACY POLICY

Personal Information

Personal Information means any information that may be used to identify an individual, including, but not limited to, a first and last name, a home or other physical address and an email address or other contact information, whether at work or at home. In general, you can visit www.jesterstheatreacademy.com without having to tell us who you are or revealing any Personal Information about yourself.

When and why we collect Personal Information from you

We only collect information about you that you volunteer to us when you make a request of us to provide information, products or subscriptions to one or more of our services. The information that we collect is required to facilitate the delivery of material, products or subscriptions you may request or order and to facilitate further communication with you.

Your Personal Information

We may collect, store and use the following kinds of personal data:
